<p>Describe how and in what capacity your business stores, processes, and/or transmits cardholder data.</p>	<p>Monetra Technologies, LLC (MT) formerly known as Main Street Softworks (MSS) designs and develops electronic direct-to-processor payment solutions. The Monetra payment application is a PA-DSS validated application assessed by a separate PA-QSA. TranSafe is the hosted version of Monetra gateway which went live September 2016.</p> <p>Monetra also has a Level 4 merchant business line for small to medium customers paying for the use of the gateway. This business line has been included in the evaluation as well.</p> <p>Card Holder Data (CHD) comes through TranSafe, hits the MT firewall, then goes to the Monetra server. From there, CHD is sent to the processor and to MT's Percona database. Data is encrypted with AES 256 and keys are managed through Gemalto HSMs.</p>
<p>Describe how and in what capacity your business is otherwise involved in or has the ability to impact the security of cardholder data.</p>	<p>The entity is a level-one service provider that processes card transactions on behalf of its subordinate merchant organizations. MT's entire business is to provide direct-to-processor electronic payment solutions to other businesses. To this end, they must transmit and store card data.</p>




